Privacy Policy

- 1.1. Confidentiality
- 1.1.1. Users shall provide accurate information. AA Sport shall not be obliged to check every piece of such information. If during the provision of the Interactive Service, AA Sport discovers that the provided information is not accurate, AA Sport shall be entitled to cancel the Interactive Service subscription, delete the user account containing inaccurate information, and inform all Partners thereof.
- 1.1.2. The User may request AA Sport to deliver the User's information held by AA Sport to the User (hereinafter: "Request") by means of a contact form for delivery and erasure of the User's information held by AA Sport. The User may use this form if the User wants their information to be deleted from AA Sport's database.
- 1.1. 3. If the User wants to have their data deleted, AA Sport will no longer be able to provide the Interactive Service to the User.
- 1.1. In case of User's data erasure upon the User's request, the User shall have rights4. stipulated by these Terms.
- 5.1.4.1. If the User's data are deleted, the User will no longer be able to use the Interactive Service and the remaining number of terms that the User has subscribed to.
- 5.1.4.2. The User agrees that the User will be entitled to claim the unused terms only in compliance with the "Complaints and Refunds" section of the Terms and the User waives their right to a refund of the paid amount commensurate with the unused terms due to inability to use the Interactive Service as a result of the User's request for data erasure.
- 1.1.5. Personal information
- 1.1.5.1. Personal information is the data that accurately identifies an individual User. For the purpose of providing the Interactive Service, the User is required to enter their personal information into a corresponding online form to be able to use a certain option.
- 1.1.5.2. Personal information such as name and surname, e-mail address, phone number, etc. is required for use of the Interactive Service and other services.

- 1.1.5.6. AA Sport stores all data in databases and servers protected by modern security technologies, with the constant implementation of security measures for the data it processes.
- 1.1.5.7. AA Sport reserves the right to deliver the User's personal information only to a financial institution (bank or other payment institution) and to the Partners who are listed as service providers through the Interactive Service, from whom the User has purchased certain membership within the Interactive Service, where such information may be

only the information that is used for the purpose of Interactive Service provision. AA Sport shall not be held responsible if the forwarded personal information is used by other persons for purposes other than the specified ones, and therefore cannot be held liable for any possible damages inflicted to the User as a result of such use by other persons.

1.1.6. General information

- 1.1.6.1. During the use of the Interactive Service, our server automatically records information sent by your browser ("Log Data") accordingly. This Log Data may contain information such as the IP address of your PC or device, the operating system of the device, the type and version of the browser or the internet page you have visited immediately before accessing the Interactive Service, parts of our Interactive Service you visited, access time and date, time spent on such parts, the information you searched for on the Interactive Service, as well as other statistical data. AA Sport shall use this information for the purpose of tracking and analysis of the way in which the Interactive Service is used, the requested and provided services, for the purpose of technical maintenance of the Interactive Service, improvement of the operation and availability of the Interactive Service, and for the purpose of better Interactive Service customisation to meet your requirements.
- 1.1.6.2. This type of information shall be automatically collected by means of electronic tools at the moment when the User is using the Interactive Service.

1.1.7. Emails

- 1.1.7.1. Upon opening an account and registration with the Interactive Service, the User shall receive emails from AA Sport, where such emails shall be Administrative Emails and Promotional Emails.

- 1.1. 9. AA Sport reserves the right to amend the Privacy Policy at any time, and such amended wording of the Privacy Policy shall become effective immediately upon publishing thereof

or as of the date specified in the Notice of the Privacy Policy Amendment through the Interactive Service or by email provided by the User during registration.

1.1.10. If the User continues to use the Interactive Service upon a Privacy Policy amendment, the User shall be considered to have accepted all terms and conditions of such amended

Privacy Policy.

- 1.2. Cookies and other automated data processing
- 1.2. When accessing the Interactive Service, AA Sport can use cookie technology and other
- similar technologies in order to identify the User's browser, i.e. in order to display

advertising. Using the Interactive Service may result in the automatic storage of certain data on the User's device, such as cookies and other similar technologies.

- 1.2.2. As part of the service, AA Sport also uses the mechanisms of external entities, partners, advertisers, which is directly related to the storage of cookies of those users on the end device.
- 1.2.3. AA Sport can use all collected information provided with the User's consent for the purpose of creating personalized offers about the services it provides, providing notifications about the expiration date and the possibility of renewing the account, as well as the possibility of contacting in connection with other projects and services offered by AA Sport and the Partner, which may be subject of the User's interest based on the processed data. The User can at any time cancel the processing for the stated purposes by contacting the customer center.
- 1.3. Payment Security
- 1.3.1. In case of payment by a payment card, the User shall enter information specified under Article 5.1.5.3 as mandatory and such date shall be considered confidential and under special protection.
- 1.3.2. Payment card confidential information shall be transferred via a public network in a protected (encrypted) form by using the SSL (Secure Socket Layer) protocol and PKI system. User's payment card data security during a purchase shall be guaranteed by the payment card processor, "WSPAY", thus the entire billing process is done in a secure environment. Payment card information is not available to our system at any moment.
- 1.4. Transfer of data abroad
- 1.4.1. The personal data that is collected is exclusively used on the territory of the Bosnia and Herzegovina and is not sent abroad.
- 1.5. Data retention period
- 1.5.1. Collected personal data is stored for the period of time required to fulfill the purpose of this contract or an express request for deletion sent by the User, after which it will be safely removed from the system and deleted.
- Data can be stored for a longer or shorter period of time than the period provided for in
- Article 5.5.1 in the case when binding regulations foresee this obligation.
- 1.6. The right to object
- 1.6.1. The User can object to the processing of personal data at any time. After an objection has been filed, AA Sport will no longer be able to process the data, except in the event that there are legitimate and justified reasons.
- 1.7. Communication
- 1.7.1. The User agrees that all interactive options, especially communication via private messages, chats, blogs, forums or other similar means of sending messages or mutual communication, are of a public nature and do not have the status of confidential information, and therefore AA Sport can monitor the specified content of the user's communication without their knowledge and special approval.

2. Underage users

2.1. Persons under the age of 15 shall not be allowed to use the Interactive Service on their own and such persons may use the page only under the supervision of their parents or guardians.

2. AA Sport's disclaimer

2.1. The User understands and agrees that the use of the Interactive Service and its content is the

4. Dispute resolution

- 4.1. All disputes that may arise out of or in connection with these Terms or Privacy Policy or in connection with these Terms or Privacy Policy or in connection with or due to the Interactive Service use between AA Sport and the User shall be consensually resolved.
- 4.2. If AA Sport and the User fail to resolve the dispute consensually, the dispute shall be brought before the Municipal Court in Sarajevo if the User is a natural person or the Municipal Court in Sarajevo if the User is a legal person.

5. Effective date

5.1.
